84TH ANNUAL WASHINGTON STATE MEN'S AMATEUR CHAMPIONSHIP

White Horse Golf Club • Kingston, Washington
June 22 - 25, 2010

Entry Deadline: June 1, 2010 at 4:30 p.m.

ELIGIBILITY

Entries are open to amateur golfers who: a) are members in good standing of a WSGA member club; and b) have a USGA Handicap Index not exceeding 8.4, at the time of entry. **There is no pre-qualifying for this event.** The field will be comprised of the lowest USGA Handicap Indexes at the close of entry, in addition to exemptions (listed on the back of this form), to fill the field of 168 players.

ENTRIES

Entrants may apply electronically via the WSGA website, www.thewsga.org (credit card will be charged at the time of entry). Entrants may also apply on a WSGA entry form obtainable from the WSGA office or downloadable from the WSGA website. An entry fee of \$200 shall be paid by every applicant (including exempt players). A full refund will be sent to those players who are placed on a wait list after entries have closed and are unsuccessful in getting into the playing field.

Online registration or signed and completed paper entries, along with the appropriate fee, must be received by the WSGA by 4:30 p.m., on June 1, 2010. Walk-in entries will be accepted anytime, but must be received by 4:30 p.m., on June 1, 2010. Entries by telephone, e-mail, fax or incomplete entries will not be accepted. Entries should be mailed early to allow ample time for delay or error. The WSGA is not responsible for lost or misdirected mail. Refunds due to cancellation on or before June 15, 2010 are subject to a \$25 service fee. **NO REFUNDS WILL BE ISSUED AFTER JUNE 15, 2010.**

Late entries will be accepted and placed on an alternate's list to fill spots if they become available up until the time that the WSGA staff establishes final pairings. Late entries will not be accepted unless they are accompanied by the correct entry fee, plus an additional administrative fee of \$25. Contestants must contact the WSGA in order to submit a late entry.

CONDITIONS

The WSGA Men's Amateur Championship Committee reserves the right to alter any of the conditions and schedules herein. The Committee reserves the right to reject the entry of any applicant, at any time, for any reason. Any decision by the Committee, in any matter, shall be final.

"SPIKELESS" SHOE POLICY

It is a condition of this competition that contestants will not be permitted to wear shoes with traditionally-designed spikes (regardless of composition, i.e., ceramic, plastic, etc.) or spikes, regardless of design, comprised either entirely or partially of metal (if such metal may come in contact with the course) are prohibited during Championship play (to include practice rounds). Contestants in non-compliance with the "spikeless" policy will not be permitted to start. Players must arrive on the tee ready to play. Extra time will not be afforded for non-metal spike installation or the changing of shoes. Failure to comply with the "spikeless" shoe policy will result in immediate disqualification.

CARTS/CADDIES

The use of automotive carts during the Championship will not be permitted. Host-club caddies may be available, contact the golf shop regarding availability. Contestants may provide their own caddie.

DRESS CODE

The WSGA expects all contestants and their caddies to wear suitable attire on the host club property throughout the duration of the championship, including practice rounds. Suitable attire does not include, cutoffs, short shorts, tank tops, jeans or denim of any kind or color, tee shirts, sweat pants or unkempt clothing of any kind. Contestants must wear neat and clean slacks, bermuda or walking shorts. Shorts must not be shorter than 5 inches above the middle of the knee. Golf shirts with collars or golf mocks are mandatory. Hats and visors must not be worn in the clubhouse. Shoes and socks must be worn at all times. Sandals of any kind are not allowed on the golf course at any time (including practice areas), even sandals with soft spikes. If additional measures are required by the host club, they will be communicated to all contestants prior to the championship and must be adhered to. Gallery must adhere to the host club dress code policy. Failure to adhere to the dress code may result in disqualification and removal from the course.

ELECTRONIC DEVICES

As a condition of this competition, the use of cellular phones, noise making pagers, radios, walkmans, iPods and any other similar electronic, noise making device will be prohibited during Championship play. Clarifications and special requests regarding this condition should be directed to the WSGA Rules Committee in advance. **NOTE:** Distance measuring devices will be allowed for this championship. Additional information regarding the local rule of using distance measuring devices will be published in the Player Confirmation and Notice to Competitors.

CODE OF CONDUCT

Unacceptable conduct or behavior on the golf course or on club property will not be tolerated and are grounds for immediate disqualification, at any time, from any WSGA Championship. **The WSGA definition of unacceptable conduct or behavior will be provided at the Championship.**

STROKE LIMIT

Players must return a score within 12 strokes of the course rating in at least one of the rounds, failure to do so will disqualify the player from future entry in the WSGA Men's Amateur for a minimum of two years.

CHAMPIONSHIP SCHEDULE

72-Hole Stroke Play Competition (Gross scores only). There will be a 36-hole cut to the low 60 players and ties. In the event of a tie, for the championship, a sudden-death playoff will be used to determine the Champion immediately following the conclusion of play.

TUESDAY, JUNE 22:

Round One: A.M. & P.M. starting times

WEDNESDAY, JUNE 23:

Round Two: A.M. & P.M. starting times

*Field cut to low 60 players and ties
Contestants re-paired by 36-hole scores*

THURSDAY, JUNE 24:

Round Three: A.M. starting times

Contestants re-paired by 54-hole scores

FRIDAY, JUNE 25:

Final Round: A.M. starting times

WITHDRAWAL POLICY

Entrants that withdraw after the entry deadline must notify the WSGA (206-526-8605) promptly in order to insure an alternate fair opportunity to play.

A "withdrawal form" will be available at registration and the scoring table and must be completed by any competitor withdrawing during the course of the championship. Entrants who unofficially withdraw (by not filling out a form or without a sufficient reason) will not be granted entry into any future WSGA event for a minimum of two years.

CONFIRMATION OF ENTRY/PRACTICE ROUND

Entrants that have met eligibility requirements will receive a confirmation of entry that will include specific practice round information and any other necessary details of the championship.

LODGING

The WSGA recommends that contestants make their lodging arrangements at the earliest possible date. The WSGA has made arrangements for reserved rooms at the following hotels. When making reservations, contestants must identify themselves as WSGA Men's Amateur Championship participants and must make reservations prior to the cutoff date.
