**5 or 7 -DAY MEMBERSHIP AGREEMENT**

This agreement is between Widgi Creek, LLC, doing business as Widgi Creek Golf Club, herein referred to as the "Club", and [ ] and, [ ] herein referred to as "Member(s)". This Membership is non-proprietary and does not confer any ownership in the property or assets of the Club, nor does it entitle Member(s) to participate in the ownership or management of the Club in any manner. This Membership cannot be sold, assigned or transferred. This Membership is good for 365 consecutive days from date of purchase and is non-refundable.

**1. Member Privileges:**

**5-Day:** Subject to available tee times, Member(s) will have use of the golf course from Sunday (after 12:00 noon) through Thursday at any time the course is open for golf throughout the Club's season. Member(s) will also have use of the practice facilities at Widgi Creek at any time the course is open for business. Tee times and the practice facilities may occasionally be limited due to maintenance requirements and special events.

**7-Day:** Subject to available tee times, Member(s) will have use of the golf course and use of the practice facilities at Widgi Creek at any time the course is open for business. Tee times and the practice facilities may occasionally be limited due to maintenance requirements and special events.

**2. 2012 Early Signup Special Fees for One Year of Membership**

**5-Day:** Single - \$1,600, Family - \$2,500

**7-Day:** Single - \$2,300, Family - \$3,200

**3. Account & Late Payment Charges**

Member(s) agree to make timely payments of all charges to Member(s)' account. If Member(s) fail to pay Member(s)' account balance in full by the end of the month following the month in which Member(s)' account charges are incurred, Member(s) agree to pay monthly late charges of \$10 or two percent of the amount owed, whichever is greater, in addition to the amount owed.

On the termination date of this membership, Member(s) will be responsible for all indebtedness incurred at the Club. Member(s) agree to pay in full all charges, late charges, and money owed within 30 days of termination. Member(s) agree to pay monthly late charges in the amount of two percent or \$10.00, whichever is greater, on any balance owed at the Member(s)' termination.

**4. Charging Privileges – Active Credit Card Required**

Member(s) will enjoy Club charging privileges for purchases made at the Pro Shop and the Restaurant. Member(s) specifically authorize the charging of Member's/Members' credit card to cover the balances owed on the Club account in the event the Club account is 30 or more days past due. Member(s) agree to keep an active credit card number with the Club. In the event the credit card is lost, stolen, or otherwise inactivated, Member(s) agree to immediately inform the Club and replace the inactivated credit card account with a new and valid credit card account. Member(s) acknowledge that failure to comply with this section will result in the refusal or suspension of charging and/or playing privileges at the Club.

**6. Waiver and Release for Member(s) and, if applicable, Children**

Member(s) hereby acknowledge that Member(s) have voluntarily applied to participate in the activities on the premises of Widgi Creek, LLC, doing business as Widgi Creek Golf Club. Member(s) understand and acknowledge that golf and other related activities may be hazardous and entail the risk of injury or death due to factors which include, but are not limited to, misuse of equipment or facilities by ourselves and others, equipment defects or malfunctions, poor physical conditioning, lightning and other acts of nature, and hazards associated with the congregations of individuals. As lawful consideration for being permitted by the Club or one of its affiliated organizations to utilize its facilities and services, Member(s) hereby agree that Member(s), Member heirs, assigns, guardians, and legal representatives will not make any claim against the Club, its affiliated organizations, or its agents for injury, death, or damage of any sort, resulting from the normal risks associated with golf and related activities or the use of the Club's facilities.

**7. Inclusion of Children in a Family Membership:**

Under a Family Membership Agreement, Member(s)' children under the age of 23 years shall have the privileges of use of the Course and Club facilities to the same extent as the Member(s). The Club in its sole discretion reserves the right to restrict children's privileges in the future based on age and maturity of said children. **Children must observe and follow the Rules and Regulations of the Club.
